The British Pharmacological Society has completed an evaluation of the Integrative Pharmacology Fund (IPF) in collaboration with the University of Exeter. The aim of the IPF was to support *in vivo* sciences in the UK. The report considers the outcomes and draws forward-looking recommendations from them. The full report is available online at
